At the B. Braun Medical headquarters in Saint-Cloud and the logistics platform in Ludres, we are continually optimizing our marketing and distribution practices on the French market, in compliance with legal, regulatory and other requirements applicable to our activities: Directive 93/42/EEC, MDR Regulation (EU) 2017/745, Good Distribution Practices and, more generally, the French Public Health Code. The reliability and ethics of our relations with healthcare professionals are also guaranteed by compliance with an internal code of conduct and by the certification of our drug promotion activity in accordance with the French Health High Authority standard.

Compliance with legal, regulatory and normative requirements (Directive 93/42/EEC, EU Regulation 2017/745), the implementation and maintenance of ISO 13485 certified quality systems as well as adherence to the MDSAP certification program according to the sites concerned, allow our products to fully meet the safety standards.
